MINUTES OF THE OUTGOING EXECUTIVE COMMITTEE

The Outgoing Executive Committee met at the Washington Hilton Hotel on August 23, 1982. The meeting was called to order at 4:10 P.M. with Bob Nichols acting as president for Jim Arima who had died during the summer. Others in attendance were: Dave Mangelsdorff (Secretary-Treasurer), Bert King (Member-at-Large), Randy Chambers (Program), Sylvia Mayer (Fellows), and Ed Eddowes (Membership). Minutes of the previous year's Incoming Executive Committee were accepted as published in the 1982 newsletter. Paul Nelson resigned as Council representative; Randy Chambers represented Division 19 at the Council meeting. Dave Mangelsdorff will resign as Secretary-Treasurer as of December 31, 1982 with Joe Fishburne taking over as interim Secretary-Treasurer. Nominations for Secretary-Treasurer, Council representative, Member-at-large, and President will be sought.

The Treasurer's report stated that the Division funds were invested in a money market fund with John Hancock which allowed check-writing in amounts of \$250 and greater. It was recommended that the Division assessment remain at the \$3 level. The Treasurer's report was approved.

Council representative Randy Chambers discussed some of the 75 issues brought before the APA Council, including: Credentialing psychologists and other health service providers, the task forces, emphasis on post-doctoral training, tightening of standards, and accrediting programs. Since Division 19 has one vote at Council, a share of 1/2 was allotted to each of the two forums (professional issues and scientific issues). How Division 19 should vote regarding whether psychologists should take a stand on political issues was discussed. It was recommended that Division 19 would vote that APA not establish a political position in general. If APA must take a stand, the facts bearing on the issue need to be presented. It was suggested that the activities of other scientific organizations with respect to political issues be examined further. Randy agreed to summarize the issues brought before Council and report to the executive committee for further guidance regarding the Division 19 position toward Council activities.

Bob Nichols presented the Awards Committee report. The 1982 recipient was Dave Mangelsdorff. It was suggested that using a special solicitation for awards was preferable to making an announcement in the newsletter.

The Nominating Committee report was presented by Bob Nichols. A three person slate for president was drawn up from the 120 nominations received. Dave Mangelsdorff was elected President-Elect.

Randy Chambers presented the Program Committee report. The submissions for the 1982 program included: 18 symposium proposals and 61 paper proposals for the 22 hours allotted. Co-sponsoring of offerings with other divisions broadened the scope of the program. A workshop was sponsored without a fee. It was suggested that the pre-convention newsletter not have the rooms listed because of confusion that resulted when the rooms were changed by the APA.

Ed Eddowes reported that the Membership Committee received 67 interest slips. There were 41 member and 4 associate applications returned. Greater dissemination of the Division 19 membership list was suggested to aid in future membership drives.

The Fellows Committee report was presented by Sylvia Mayer. From five (cont.)




For meritorious scientific and professional contributions to military psychology.

applicants, two candidates were nominated. Both candidates were rejected by the APA Membership Committee. The recurrent problems were cited: candidates not publishing in refereed journals (preferably psychology), not being known outside of military circles, and not contributing to the advancement of psychology. Fellows need to recommend more candidates and candidates need to line-up fellows from other divisions to recommend them. Candidates need to be aware of the criteria for nomination, specifically: member of APA for 5 years, publish in refereed journals, make outstanding contribution to psychology (more than military research), and be known outside of military circles.

The reports of the ad hoc committees followed. Bob Nichols reported for the Ad Hoc Committee for Psychologists in Uniform. APA has studied the standards for military psychologists and the three services currently are responding to (cont.)

APA concerns. The issues involve the lack of uniformity of standards in the DoD and whether state licensure would allow comparability.

There was no report from the History of Military Psychology Committee, the problem being obtaining clearance for individual reports. The Ad Hoc Committee on Human Factors report was given by Randy Chambers. Contributions and technical achievements in rehabilitation engineering for civilians and veterans with handicaps were cited as part of the concerns with helping the handicapped. The Ad Hoc Committee on Selection and Training was reported by Ed Eddowes. Currently the major concerns focused on pilot selection, combat success and acquisition and retention of individual skills. A symposium, "Military Developments in Computer Assisted Selection Systems" was organized and presented at the 1982 APA Convention sponsored by the Committee. Dave Mangelsdorff presented the newsletter report. Three newsletters were published, the third, a preconvention issue contained a member survey. Dave had received 50 survey forms at the time of his report.

Bert King presented the report of the Ad Hoc Committee on International Relations. The Committee hopes to act as a clearinghouse for information. The NATO Managerial Behavior and Leadership Conference had little to offer about military issues. The International Applied Military Psychology meeting in London dealt with women in the military, job satisfaction, use of inexpensive simulators in training, and selection. The International Association for Applied Psychology Conference met in Edinburgh; it had some interesting sessions, particularly on officer selection. APA was not helpful on other international relations activities.

New business centered on reforming committees. Bert King (Member-at-large) will assist in the Awards Committee, replacing Jim Arima. Randy Chambers will serve as interim Representative to Council and Joe Fishburne will serve as interim Secretary - Treasurer. Other issues addressed to Division 19 included: establishment of a peace mission or a National Peace Academy, representation at a Competence Evaluation Conference on credentialing, and Division Liaison officers to assist in working on APA projects. Several questions were raised, among them, what should Division 19 do with respect to distressed psychologists, new divisions in APA, psychological assistance in health care and interactions with APA headquarters.

There being no further business, motions were made, seconded, and carried that the meeting be adjourned.

MIMUTES OF THE ANNUAL BUSINESS MEETING

The annual Division 19 business meeting was held at the Washington Hilton Hotel, Washington, D.C. at 1:05 P.M. on August 25, 1982. The meeting was called to order by acting president Bob Nichols with 22 members present at the start of the meeting. Bob Nichols informed the members of the death of President Jim Arima on July 16, 1982. A letter to Mrs. Arima from the APA expressing concern at Jim's death was read. Ralph Dusek, Past President and chairman of the Awards Committee, presented the Awards Committee report. The Military Psychology Award was presented to A. David Mangelsdorf for his early career contributions to military health psychology. The Award citation appears in the newsletter.

Bob Nichols presented the Nominations Committee report. A three-member (cont.)

slate of candidates was proposed for president. The members voted Dave Mangelsdorff President-Elect.

Dave Mangelsdorff gave the Treasurer's report. It is presented in the newsletter. It was recommended and approved that the reading of the minutes of the 1981 Annual Business Meeting be suspended. The 1981 minutes were accepted and approved as published in the 1981 newsletter. Following the Treasurer's report it was recommended that Division 19 funds continue to be held in the mutual fund account. A recommendation to continue the present Division assessment was approved. The proposed 1982 - 1983 budget of \$3000 was approved.

The report of the Representative to Council was given by Randy Chambers. Of the 84 issues before the Council, several were of interest to Division 19. These included: 1) A task force on disaster control (Division 19 supported this proposal. It was defeated by Council.), 2) Nuclear disarmament (Division 19 was neutral.), 3) Each division would decide on the criteria by which fellow candidates would be evaluated, and 4) The doctoral degree would be emphasized for practice in psychology. Only a few of the issues had been voted upon at the time of the Business Meeting.

The Program Committee report was presented by Randy Chambers. The theme for the 1982 program was War and Peace. The contents of the program are noted in the minutes of the Outgoing Executive Committee meeting. Problems encountered included difficulties in coordinating with the APA on outside invited speakers and an increase in the number of program participants who failed to show up for their presentations. It was noted that a participant must notify the session chairperson if unable to attend, or to make suitable arrangements to fully discharge the commitment to participate. It was moved, seconded, and approved that the Division would not accept future submissions from persons who fail to honor their commitments to make presentations.

The Membership Committee report was presented by Ed Eddowes. Details of this report are provided in the minutes of the Outgoing Executive Committee. The Fellows Committee report was given by Sylvia Mayer. In addition to the material also found in the minutes of the Outgoing Executive Committee, it was requested that nominations for fellow status be solicited through the newsletter and that Fellows recommend as candidates members who satisfy the criteria used by the APA Membership Committee in evaluating candidates.

Al Wooten gave the report of the Ad Hoc Committee for Psychologists in Uniform. The issue of licensure for psychologists in uniform was discussed. Among the problems noted were the management of clinicians, staffing based on population analyses rather than patient services, revision of the regulations on health care delivery, and credentialing of psychologists. The DoD is requesting the chiefs of the armed services to decide on the licensing of psychologists in uniform.

Henry Taylor reported for the Relation of Psychology to Public Policy Committee. The Committee suggested that Division 19 should take no action on public policy at this time. Instead, the Division should move cautiously through established military and APA channels.

Herlie Hendrix reported for the Ad Hoc Committee on Organizational Psychology. The Committee is attempting to establish an information network and is coordinating its efforts with Division 14.

The Ad Hoc Committee on Women and Minorities in Military Psychology report was presented by Jo Hunter. The Committee had sponsored a symposium for the 1982 APA Convention. Attention had been focused on a speech at the Convention by Sharon Lord on how best to utilize women in the armed forces. The Committee will continue its activities and will be chaired by Anne Hoiberg, who will relieve Jo Hunter.

Marty Wiskoff discussed the Military Psychology brochure which will be updated and published in the future. The objective of the brochure is to tell what the Division of Military Psychology is about. The brochure will serve many purposes.

Paul Nelson reported for the Credentialing and Education Committee. He recommended that the Division work through existing APA structure rather than by a separate ad hoc committee. Randy Chambers reported on the Ad Hoc Committee on Human Factors and Engineering Psychology stating its concern with helping the handicapped through rehabilitation engineering. Dave Mangelsdorff reported on the newsletter, noting that use of a mailing permit helped reduce newsletter costs.

Committees were reformed as shown in the list of officers and committee chairpersons and members. There being no further business, the meeting was adjourned.

MIMUTES OF THE INCOMING EXECUTIVE COMMITTEE MEETING

The incoming Executive Committee met at 4:05 P.M. on 26 August 1982 at the Washington Hilton Hotel, Washington, DC. President Bob Nichols called the meeting to order. The attendees were: Ed Eddowes (Newsletter), Richard Bloom (International Relations), Joe Fishburne (Secretary-Treasurer), Bob Penn (Program), Bert King (Member-at-large), Randy Chambers (Representative to Council), Marty Wiskoff (Member-at-large), Dave Mangelsdorff (President-Elect), Arthur C. F. Gilbert, and L. R. Chominski. New members were selected to committee vacancies: Bert King (Awards), Steve Parkinson (Program), Frank Petho (Membership), Arthur C. F. Gilbert (Fellows), and Arthur C. F. Gilbert (Organizational Psychology).

Bob Penn (Program) asked about funds for invited speakers; a small honorarium of up to \$200 was made available. APA Council must vote on any invited speakers who are not APA members and this must be scheduled for Council review in time for the January meeting. Guidance for invited speakers can be obtained from the APA Board of Directors. Penn suggested that his intent would be to develop symposia and speakers rather than paper sessions, particularly through joint sponsorships with other divisions. Richard Bloom (International Relations) will attempt to publish information about international researchers, their interests and practices.

On the recommendation of the Membership Committee Chairman, it was voted to reinstate Jeff Koonce as a member of Division 19. The Organizational Psychology Committee will continue its coordination with Division 14.

New business included: establishment of a National Peace Academy, representation at a Competence Evaluation Conference on credentialing (Joe Fishburne will attend on behalf of Division 19, but will pay his own fees), liaisons with APA (not formally needed), JCAH position on credentialing (each service will write its own response). Other issues were discussed: distressed psychologists, gays, archives (Division 19 material will be assessed for possible deposit in the APA archives), nominations for APA professional contributions. The meeting was adjourned after appropriate motions were made.
