## PRESIDENT'S MESSAGE

It is time to wrap up what has happened in the last few months and to assess the progress on my original four goals. To reiterate, my goals were: 1. Establishment of an effective communication network, 2. Establishment of a journal, 3. Expansion of Division membership, and 4. Definition of the direction of the future of Division 19. Progress has been good on all goals. The Network appears to be stimulating some interest and reaching more members than in the past. I have been keeping informed by teleconferencing with the Psychologists in Uniform group; they will host a breakfast at the Convention to bring uniformed psychologists up to date on current issues. I will be at the breakfast to present the results of a survey which I am conducting of all uniformed

military psychologists. The survey was intended to inform uniformed psychologists about Division 19 and to ask whether they would be interested in more information about Division 19 (perhaps even to join). In fact, there have been many requests for information about Division 19 generated (which supports my third goal).

In addition, the survey will document the issues which are of concern to uniformed psychologists. I believe that a report put together by Division 19 would be perceived as less biased than a report from one of the services. The findings and recommendations of the uniformed psychologist survey will be provided to the psychology consultants of the services and to Department of Defense Health Affairs. If you have received the survey and not returned it, please do so. In addition, please ask your uniformed psychologist colleagues to return their surveys as well. If there is interest (and I have enough energy), I may repeat the same effort with the civil service employees and with the reserves.

The Journal of Military Psychology continues to make progress. Please continue to send your contributions to Glenda Nogami. Support your Journal by submitting your best work.

My apologies for a slip in the nominations procedure; we did not use the most current roster in the mailing, so we omitted some potentially fine candidates. Sorry about the error.

I have edited and submitted to the Defense Technical Information Center (DTIC) the proceedings of all the Army psychology symposia from 1958 to 1982 as well as the proceedings of the Combat Stress Workshops (three so far). I really appreciate the support from Wendel R. Wilkin and Jim Hedlund for providing some of the earlier proceedings. When the accession numbers become available from DTIC, I will let everyone know what they are and how to obtain copies. The proceedings provide a fascinating insight into the historical development of the Army psychology programs. My next project will be to provide a subject and author index for these volumes (it should be available next summer).

In August, the APA journal <u>Professional Psychology: Research and</u> <u>Practice will publish my article on "Issues affecting Army psycholo-</u> <u>gists' decision to remain in the service: A follow-up study." I plan</u> to make copies available to all psychologists in uniform as well as to those interested. Later this year, the Journal of Community Psychology will publish another article, "Lessons learned and forgotton: The need for prevention and mental health interventions in disaster preparedness" which will be informative to those of you who consult on combat readiness/ preparedness topics.

I plan to contact the members of the Network and the Executive Committee to attempt to arrange for planning the future direction and goals of Division 19. One of the possibilities is to get selected members together at a central location for some interactive goal setting/ brain storming sessions. The meeting should take place in December with

an agenda still to be developed. More on that later.

There are a few details about the Convention. Varying APA Committees and Boards are requesting that representatives from Division 19 attend selected meetings. In addition, be aware of the planned demonstrations by coalitions of animal rights groups.

I would like to recommend a pair of volumes which I believe will be of interest to many of you. <u>The Women of Psychology</u>, Volume 1: Pioneers and Innovators and Volume II: Expansion and Refinement. These excellent books were written by Gwendolyn Stevens (a member of Division 19) and Sheldon Gardner. The authors are to be commended for their fine contribution to the professional literature. The publisher is Schenkman Publishing Co., Cambridge, MA.

Earl Alluisi suggested that Division 19 might wish to become more involved with the <u>Psychological Documents</u> publication. His suggestions include making a synoptic journal which would be of interest to scientists/practitioners in areas of interest to members of Divisions 14, 19 and 21. Any comments on Division 19 participating in such an enterprise?

Most importantly, I need to personnaly thank all of the members of the Division 19 Network for putting up with my garbled directions and requests. I would like to complement Ed Eddowes and Mike Strub for their fine efforts with the Newsletter. Bob Gregory is to be congratulated for what looks like a great Convention program. Joyce Shields has been outstanding in bringing in new members. Bert King and Laurie Broedling have been exceedingly helpful. Glenda Nogami has been quite successflu with The Journal of Military Psychology. Bob Nichols has kept us well informed on APA Council matters.
