PRESIDENT'S MESSAGE

Dick Bloom

What's the best part of serving as Division 19 President? Becoming better acquainted with our membership's outstanding accomplishments. Our members have contributed much towards science, professional practice, education, and the public interest. Feedback from the officers of other APA Divisions during the 1992 Leadership Conference indicates that they also are impressed by our accomplishments. At the conference, outgoing APA President Charles Spielberger again cited our colleagues associated with Desert Shield/Desert Storm - not just our clinicians, but the many of us who contributed through

accomplishments past and present in personnel selection, human factors, and the many other areas of military psychology.

Now for the latest on Division activities. The proposal to add an opinion section for psychological research on military and politico-military issues to our journal, <u>Military Psychology</u> has been evaluated and placed aside for the time being. We are looking for more traditional research contributions in all areas of military psychology. The Journal, under **Martin Wiskoff's** guidance, has a reputation for excellence. To maintain this excellence, a continual flow of contributions is needed. Please get the word out to your colleagues to submit manuscripts.

The proposal to develop a new edition of <u>Military Psychology: An Overview</u> is being implemented. **Thomas Zazeckis** is the coordinator for the project and is working closely with **Jimmy Mitchell**, **James Griffith**, **Robert McCullach**, and **Roger Bryant**. There will be significant progress to report at the 1992 APA Convention.

As to the Convention, James Georgoulakis and Program Committee members Denise Feducia, James Harris, and Diane Williams have expended extraordinary effort evaluating many proposals. There will be much cosponsoring of programs with other divisions, a breadth of topics, and several exciting invited addresses. The committee did a great job. So has Paul Gade in developing our pre-convention workshop.

Joseph Fishburne was able to develop the seeds of an agreement with Division 21 so that it and Division 19 can form a coalition for the next 2 years, assuring representation at APA Council. (This was made possible by our successful 1992 drive for apportionment votes.) I'm working out the details to bring Joseph's alliance-building to fruition.

James Harris is working on increasing Division membership and following up on initiatives brainstormed by the Division 19 Executive Committee. Your help is requested in passing on the membership application in this newsletter to interested candidates.

Our Science Committee is developing the concept of circulating one-page position papers on how scientific psychology can elucidate military issues. This may be a significant contribution to psychologists and others. The papers would be coordinated with the Executive Committee and then sent to APA Central Office before distribution.

The Executive Committee, especially **Deborah Rogers**, has been hard at work managing finances and other nuts and bolts issues crucial to our viability. Your officers are putting in much time and effort for our collective benefit.

The current APA President, Jack Wiggins, has identified crisis psychology and psychology emergency services as priority issues during his presidency. Many military psychologists have created crisis intervention and emergency services teams and some have even commanded them. If you have manuals and procedures that have been approved for release, I encourage you to send them to Jack.

MINUTES OF DIVISION 19 MID-YEAR EXECUTIVE COMMITTEE MEETING

Division President Richard Bloom called the Mid-year Executive Committee Meeting to order at 0900 on 10 February 1992 at the HumRRO's offices, Alexandria, Virginia. The following individuals were present at the meeting: Dick Bloom, President, Brian Waters, President-Elect, Jared Jobe, Past-President, Steve Goldberg, Secretary, Deborah Rogers, Treasurer, Joseph Fishburne, Council Representative, Russ Hibler, James Harris, Mike Fischl, Paul Gade, Alma Steinberg, Dave Payne, Deirdre Knapp, and Jim Georgoulakis.

Dick Bloom began the meeting by stating that the Division was in a state of moderate crisis due to the confusion over membership and its impact on the Division's financial status. The Executive Committee then developed options to resolve the crisis. Dick went on to review his attendance at the recent APA Leadership Conference and discuss other APA related information of interest to Division 19. With regard to the upcoming ban on Department of Defense advertising in APA journals, Dick noted that Division 44, The Society for the Psychological Study of Lesbian and Gay Issues, would like to develop an operational definition for what constitutes progress toward DoD admitting gays and lesbians.

James Harris gave the Membership Committee report. As of January 1992, there were 444 paid individuals in Division 19. There is a discrepancy between the number of members we think we have and what Division Services in the APA Central Office believes we have. There was a discussion about how to increase the Division's membership. Ideas generated included flyers for AERA, Division 19 application in the newsletter, and the possibility of some kind of relationship with the American Psychological Society.

Henry Thomas, Executive Director, Public Interest Directorate, APA, and Bill Bailey, APA Public Policy, spoke about the gays and lesbians in DoD issue. They spoke about the resolution that had been passed by Council to withdraw DoD advertising from APA publications unless DoD changes its policies toward gays and lesbians. The APA Board has also voted \$6,000 to hold a meeting on gay and lesbian issues in the military. Council is expected to concur with providing the funds for this purpose. Brian

Waters noted that DoD is not commenting on the issue and that the only way to change the DoD policy is from outside, either from the Congress or through a Presidential Directive.

Jim Mitchell and Jim Griffith have agreed to update the Military Psychology Pamphlet. Thomas Zazeckis will be the coordinator.

The financial report reflected the Division's membership problems. We have debts of \$6,200 from last year. Money is owed to Lawrence J. Erlbaum for the Journal and to APA. Negotiations to reduce our debt with both these parties were discussed. Money for this year is tight, but there should be enough to cover expenses.

Jim Georgoulakis spoke on the upcoming convention program. Dr. Enrique Mendez, Assistant Secretary of Defense for Health Affairs will be one invited speaker. There will be a social hour following his talk and a second social hour following **Dick Bloom's** Presidential Address. Jim noted a decline this year in the number of submissions. Uniform and clinical issues were particularly under represented. The program committee will need at least two new members for next year.

There will be a pre-convention workshop this year, organized by **Paul Gade**. The workshop will be entitled "Military Psychology and its Contributions: Historical Perspectives." The workshop is in conjunction with APA's 100th anniversary celebration at this year's convention.

Joseph Fishburne reported on upcoming Council activities. He said that the agenda for the February meeting was light, with no controversial items. He did ask for guidance on the position the Division should take toward the gays and lesbians in the military issue. Division 19 will not have a council representative next year unless we form a coalition with another division. We will regain our seat the year after. Given that both Division 19 and Division 21, Division of Applied Experimental and Engineering Psychologists, are close each year to either maintaining or losing their seat, the possibility of a coalition with Division 21 for the next 2 years was discussed. (See President's Message, on page 2, for update.)

Martin Wiskoff reported on the Journal, <u>Military Psychology</u>. Submissions are still barely adequate to meet the page requirements for the Journal. The Journal published its first Special Issue this past year and is working on an issue dealing with continuous operations for the coming year.

Alma Steinberg, Newsletter Editor, said that there will be two newsletters this year. March 30 will be the deadline for the Spring/Summer issue.

Committee Reports

Nominations and Elections. Jared Jobe reported that five people were nominated for Division President. All in all, there were not a lot of candidates or people voting.

Awards. The Awards committee consists of the Division President, Past-President, President-Elect. In Greenberg received last year's Yerkes Award. There was no Military Psychologist award for last year. Nominations received for the award did not include enough back-up information to justify its award. There have been no nominations for this award received so far this year. Paul Gade nominated Meredith Crawford for a Lifetime Achievement Award. The nomination was approved by the Executive Committee 5-0.

<u>Fellows.</u> **Mike Fisch!** presented the committee report for **Jim Regan**. One person has been recommended for Fellow status by the Division. The name has been forwarded to APA for approval. March 15 is the deadline for fellows applications.

<u>Practice.</u> Russ Hibler gave the Practice Committee report. He presented an update on the trial program for allowing psychologists to have prescription privileges. The program is running into opposition from the American Psychiatric Association. Professional pay is still on hold. New business included discussion of a new APA <u>Ethical Principles</u> draft whose confidentiality section has an impact on Uniformed Psychologists. Force reductions in the Air Force are reducing the number of colonel psychologist slots. There will be a Tri-Service Aviation Psychology course given at Ft. Rucker.

<u>History</u>. **Paul Gade** met with Division 26, History of Psychology, and encouraged cooperation with our Division. He invited Division 26 members to submit articles to <u>Military Psychology</u>.

Women and Minorities. A new chair for this committee is needed and we are soliciting nominations.

YERKES AWARD TO IRV GREENBERG

On September 10, 1991, Jared Jobe, Brian Waters, Deborah Rogers, and Steve Sellman presented the Robert M. Yerkes Award to I. M. Greenberg in a ceremony at the Logistics Management Institute, Bethesda, Maryland. Over 100 of Mr. Greenberg's colleagues, friends, and family watched as he received the Division 19 award for contributions to military psychology by a non-psychologist, and then attended a post-ceremony reception.

Mr. Greenberg has been a notable manager, researcher, and implementer within the military manpower arena. Among his accomplishments, Mr. Greenberg was Director of Project 100,000 under Secretary of Defense Robert S. McNamara. For this 1960s War on Poverty Program, he designed and established a database, implemented and monitored the New Standards program, and reported on its progress including contributions to the literature. Later, Mr. Greenberg also played a role in the development and nurturance of the precursor to the Defense Manpower Data Center (DMDC), which was then known as the Manpower Research and Data Analysis Center.

Prior to retiring from the Federal Government, Mr. Greenberg was the Deputy Assistant Secretary for Program Management within the Office the Assistant Secretary of Defense for Manpower, Reserve Affairs, and Logistics. He also served as Staff Director for President Reagan's Military Manpower Task Force which culminated in a report on the status and prospects of the All-Volunteer Force.

Mr. Greenberg's contributions to military manpower research and policy continued after he retired from the Government. He became manager of the Washington Regional Office of McFann-Gray and Associates where he was involved in the design and conduct of military training and job performance research. His analysis and discussion of the performance of men erroneously enlisted during the ASVAB misnorming era have been and continue to be highly regarded and frequently cited.

Today, Mr. Greenberg holds a senior position with the Logistics Management Institute. His wise counsel regarding military manpower policy is still actively sought. For example, he served as advisor to the Office of the Assistant Secretary for Educational Research and Improvement, U.S. Department of Education, regarding a conference on the effects of Defense downsizing. He reviewed papers for the conference and offered valuable advice regarding content issues for discussion. In honor of his past and present contributions to military psychology, Mr. Greenberg was presented the 1991 Yerkes Award.



- (b) <u>member status</u> Member of APA, selection for election to membership by the Membership Committee of the Division, and approval and election to membership by the Executive Committee of the Division.
- (c) <u>associate status</u> Associate of APA, selection for election to associateship by the Membership Committee of the Division, and be approval and election to associateship by the Executive Committee of the Division.
- (d) <u>affiliate status</u> selection for election to affiliate status by the Membership Committee of the Division and be approval and election to affiliate status by the Executive Committee of the Division. Affiliate status does not require any category of member status in APA.

All membership classes of the Division will receive the Division journal, <u>Military Psychology</u>, and newsletter, <u>The Military Psychologist</u>. In addition, membership in the Division entitles individuals (other than affiliates) to vote on all Division matters and also provides the opportunity to submit papers for consideration by the Division for presentation at the annual APA Convention.

All new applications for membership in the Division of Military Psychology will be processed and individuals added to a list of new members and associates. This list will be sent to APA headquarters and your new Division 19 status will be noted in your APA dues statement.
